The Town of North Brentwood election for 2 council seats will be will be held on Monday, May 7, 2018. Polls open from 1-7 PM at the North Brentwood Municipal Center, 4009 Wallace Road, North Brentwood, Maryland. Please use the side entrance of the building.

Voter registration

If you are registered to vote with the Prince George's County Board of Elections, and reside at a North Brentwood address, then you are registered to vote in Town elections. All new voter registrations and changes of address must be received by the Prince George's Board of Elections by April 9, 2018. Voter registrations forms are online http://www.elections.state.md.us/voter_registration/application.html (Note: there is an underscore between 'voter' and 'registration' in the web address.)

Absentee Ballots

Voters who will be absent from the Town election (and who cannot personally appear to vote at the polls on Election Day because of illness or physical disability) may apply to vote by Absentee Ballot. An application or letter stating the need for an absentee ballot (including the reason why you will not be able to appear personally) must be received at the Town office no later than April 24, c.o.b. 1 PM. Your application or letter will be reviewed and you will be sent an absentee ballot. The ballot must be sealed in an envelope, mailed and received at the Town office by Thursday, April 27, 2018, c.o.b. 1 PM.

Qualification of Candidates wishing to run for the opened council seats

Candidates for the Council Seats must have resided in the Town for at least 1 year (immediately preceding the election) and be a qualified voter of the Town.

Petitions for Candidates

For a candidate's name to be placed on the ballot, he or she must submit a petition for councilmember candidacy to one of the election judges. The petition for the councilmember seat requires 10 signatures of registered town voters. It is advisable to get more than 10. The petitions may be obtained at the Town's office or from Town's website: www.northbrentwood.com. Your petition must be delivered to one of the election judges no later than Monday, April 9, 2018 c.o.b. 5:30 PM. Petitions must be submitted to Attn: Board of Supervisor of Elections, Town of North Brentwood, 4009 Wallace Road, North Brentwood, Maryland 20722. Election judges will certify each petition.
