



RESOLUTION NO. 2015-03

A resolution to approve and accept the application and receipt of financing for a Community Legacy, Community Legacy-Neighborhood Intervention, Strategic Demolition and Smart Growth Impact Fund, Baltimore Regional Neighborhoods Initiative or other State Revitalization Programs Project (s) (the "Project") further described in the application dated July 15, 2015 (the "Application") to be financed either directly by the Department of Housing and Community Development (the "Department") of the State of Maryland or through other departments or agencies of the State of Maryland.

WHEREAS, Town of North Brentwood recognized that there is a significant need to reinvestment and revitalization of the communities in Prince George's County; and,

WHEREAS, the Department, either through Community legacy, Community Legacy-Neighborhood Intervention, Strategic Demolition and Smart Growth Impact Fund, Baltimore Regional Neighborhoods Initiative [or other State Revitalization Programs] or through other Programs of the department, or in cooperation with other State departments or agencies, may provide some or all of the financing for the Project (the "Project Financing") in order to assist in making it financially feasible; and,

WHEREAS, the Project is located within a priority funding area under Section 5-7B-02 of the Smart Growth Act and the Project will conform to the local zoning code; and,

WHEREAS, the applicable law and regulations required approval of the Project and the Project Financing by Town of North Brentwood and, where appropriate, by the chief elected executive official of the local subdivision;

NOW, THEREFORE, BE IT RESOLVED THAT, Town of North Brentwood hereby endorses the Project in the Sustainable Community Area; and **HEREBY** approves the request for financial assistance in the form of a grant or loan, up to the amount of \$35,000.00; and,

BE IT FURTHER RESOLVED THAT, the chief elected executive official be, and is hereby requested to endorse this Resolution, thereby indicating her approval thereof; and,

BE IT FURTHER RESOLVED THAT, the Mayor is hereby authorized to execute documents and take any action necessary to carry out the intent of these resolutions; and,

BE IT FURTHER RESOLVED THAT, copies of this Resolution are sent to the Secretary of the Department of Housing and Community Development of the State of Maryland.
